### **Summary:**

Alcohol abuse on our nation's waterways as well as our highways and other roadways remains at epidemic proportions. Alcohol use continues to be among the leading known contributing factors in fatal boating incidents with 254 incidents in 2018, ranking sixth out of 10 for primary contributing factors of incidents. In 2016, alcohol-impaired driving crashes accounted for 28% of all traffic-related deaths in the United States. In 2017, nearly 11,000 people died in a drunk driving crashes. That equates to one death every 48 minutes and does not include alcohol-related fatalities on the water. According to the Centers for Disease Control (CDC), the societal costs of excessive alcohol use just related to law enforcement, criminal justice and motor vehicle crashes alone totals more than \$40 billion annually.

This proposal is for one year. The National Association of State Boating Law Administrators (NASBLA) is seeking grant funding to collaborate with the National District Attorneys Association (NDAA) in the development of a training module. This training would enhance courtroom preparation for prosecutors of boating under the influence (BUI) cases brought forth by state and local officers. NASBLA, in partnership with the NDAA, intends to bridge the gap between successful and unsuccessful prosecution of BUI by assisting prosecutors in better preparing themselves for courtroom testimony. This training, in preparation for the adjudication of BUI cases, will strengthen officers' ability to successfully recall and communicate to a judge and jury the facts and informed opinions that resulted in the decision to arrest made by the officer. To accomplish this, NASBLA will collaborate with NDAA to create an integrated

prosecution training module (Courtroom Preparation Module) to supplement existing BUI training curriculum to improve outcomes nationwide in the effective prosecution of BUI cases.

As the voice of America's prosecutors, the NDAA and its National Traffic Law Center (NTLC) provide invaluable training, continuing education and professional development to the nation's prosecutors and law enforcement partners each year. Utilizing a nationwide network to deliver targeted training in multiple areas of criminal justice expertise, the NDAA helps local prosecutors bring the science of alcohol impairment, detection and enforcement together in a classroom setting side-by-side with officers who will ultimately assist in the prosecution. Combined with NASBLA's decades-long program to teach BUI detection and enforcement to water patrol officers, this collaborative initiative will leverage the experience and expertise of both segments of the criminal justice system to achieve better outcomes in BUI prosecutions.
