Summary:

NASBLA is seeking grant assistance and Coast Guard support to codify boating accident investigation standards. This project will directly address Area of Interest 4, Development of Boating Accident Standards of Investigation. While recreational boating data is collected via many sources, the most critical data is collected through the Boating Accident Report Database (BARD) system. BARD collects data from every reportable boating accident in the United States and that data is collected by boat accident investigators trained mostly by NASBLA.

NASBLA has been accredited by the American National Standards Institute (ANSI) as a Standards Developer (SDO).

For FY21, NASBLA is seeking funding to develop Boating Accident Standards of Investigation following the ANSI Standards Development process. NASBLA plans to follow the ANSI Essential Requirements to develop the standard in hopes of submitting it in the future as a new American National Standard (ANS). Formalizing the methods and processes of boating accident investigation and the resulting boat accident reports will ensure correct, concise information is being reported across all reporting agencies.
